TERMS OF REFERENCE

Instrument of Appointment and Delegation

1.0 NAME

The Committee shall be known as the Corrigin Bush Fire Advisory Committee (Committee).

2.0 ROLE OF THE ADVISORY COMMITTEE

To formulate for Council's consideration, recommendations and policy on matters relating to bush fire prevention, control and extinguishment.

3.0 OBJECTIVES OF THE ADVISORY COMMITTEE

- To advise Council on all matters relating to the operations of the Bush Fires Act 1954.
- To advise Council on the best and most efficient means of maximising fire control resources in the district.

4.0 MEMBERSHIP

The Council appoints to the Committee those ex officio representatives listed in the categories of membership outlined below. Membership of the Committee shall, unless otherwise specified, be for a term ceasing at the date of the Local Government election in the year the Shire's local government elections are held, after which time the Council may appoint members for a further term.

Council may dismiss members who miss two consecutive meetings without reasonable cause. Membership of the Committee shall be:

- The President of the Shire of Corrigin.
- The Chief Bush Fire Control Officer (CBFCO).
- The Deputy Chief Bush Fire Control Officer (DBFCO).
- One Bush Fire Control Officer (appointed by the Shire in accordance with the Bush Fires Act 1954) from each Brigade.
- One Councillor nominated by the Council.

Chief Executive Officer and other Shire staff members will provide advice and administrative support to the Committee.

A Representative from Department of Fire and Emergency Services (DFES) Great Southern Region and any other agency as determined by the Presiding Member will be invited to attend and provide reports on their respective agencies.

5.0 PRESIDING MEMBER

The President takes the role of Presiding Member. The members of the Committee shall elect a Deputy Presiding Member to chair in the absence of the Presiding Member.

The election of the Presiding Member and the Deputy shall also be required to be repeated at the first meeting after the local government election to satisfy the requirements of the Local Government Act.

This can be facilitated by the CEO or the CEO's representative conducting the election calling for a motion to confirm the election of the CBFCO and the Deputy Chief Bush Fire Control Officer.

The Presiding Member shall ensure that minutes of the proceedings are kept and that business is conducted in accordance with the Shire of Corrigin Standing Orders.

The minutes of the Committee are to be submitted to the next ordinary meeting of the committee for confirmation. The person presiding at the meeting at which the minutes are confirmed is to sign the minutes and certify the confirmation. The Local Government Act 1995 places responsibility for speaking on behalf of Council with the President, or the CEO if the President agrees. The Presiding Member if not the Shire President as well as individual members of the Committee are to refrain from speaking publicly on behalf of the committee or Council, or to issue any form of written material purporting to speak on behalf of the committee or Council without the prior approval of the Shire President.

6.0 CONDUCT OF MEETINGS

Ordinary meetings of the Committee shall be held on a day as determined by the Presiding Member generally in April or May and October or November each year. Written notice shall be given to all Committee members, at least 14 days prior to the meeting. Special meetings of the Committee may be convened:

- By the Presiding Member
- By written notice to all Committee members, such notice being signed by at least four members of the Committee, giving not less than 7 days notice and stating purpose of the meeting.
- By the Council

The time and venue of meetings will be determined by the Presiding Member or the Council having due regard to the general convenience of the Committee members.

The Committee is established by the Council of the Shire of Corrigin under the powers and given in section 5.8 of the Local Government Act 1995 and under section 67 (Advisory Committees) of the Bush Fires Act 1954. Notice of meetings, quorum requirements of 50% of members and all other matters pertaining to the conduct of the committee shall be carried out in accordance with the Local Government Act 1995.

7.0 DELEGATED POWERS

The Committee has no delegated powers and is an advisory committee to Council only. Recommendations of committees meetings are to be presented to Council by Shire staff for noting or for consideration as soon as practicable after unconfirmed minutes of Committee meetings are available.

6. GENERAL BUSINESS

1. Fire Reports

6. Bush Fire Radios

7. Firebreak Order 2021/2022

The firebreak order was reviewed.

Process for issuing reminders and infringements for breaches of fire break order was discussed. Members were asked to provide detailed information such as date, time, location and photos in order to substantiate a breach of the fire break order.

8. Burning Permits

Members were reminded to tick box on permits issued early in the season requiring landholders to notify shire on the day they are burning. This is very helpful when we receive calls from members of the public asking if help is required at a fire.

Following questions raised at the Fire Control Officer's Course and by community members the relevant section of the Bush Fires Regulations 1954 were discussed including the obligations of permit holders.

15B. Permit to burn holder, duties of

- (1) Subject to the Act a person who has obtained a permit to burn the bush under section 18 of the Act (in this regulation called the *permit holder*) shall comply with the conditions set out in this regulation in relation to the burning of the bush.
- (2) The permit holder shall give notice of his intention to burn the bush upon land, or upon a part of land, to
 - (a) the chief executive officer or a **bush fire control officer** of the local government in whose district that land is situated; and
 - (b) the owner or occupier of all land adjoining that land; and
 - (c) a forest officer if the bush is situated within 3 km of forest land; and
 - (d) an officer or employee of each notifiable authority (if any), being an officer or employee who is apparently authorised to accept that notice.
- (3) The period of notice required under subregulation (2) shall **not be**
 - (a) more than 28 days; or
- (b) less than 4 days unless the notice is given verbally in which case the minimum period of notice may be determined by mutual agreement.
- (4) Notice required to be given to an owner, occupier or other person under subregulation (2) may be given by any of the following methods—
- (a) by verbal communication or in writing as will ensure (except in the case mentioned in paragraph (c)) that every owner, occupier or other person is made aware of the intention to burn and the date and time thereof; or
- (b) by delivering it at the premises on which the person to whom notice is to be given lives or carries on business or by leaving it with a person who is apparently over the age of 16 years who resides or is employed on the premises; or
- (c) in the case of an owner or occupier of adjoining land who is not at the time residing on the adjoining land by posting, not less than 8 days prior to the first day on which it is intended to burn the bush, the notice by prepaid letter

addressed to the last known place of abode or business of the owner or occupier.

- (5) A notice given under subregulation (2) shall contain full particulars of the locality where the bush proposed to be burnt is situated.
- (6) Before setting fire to the bush the permit holder shall arrange for and provide, in order to assist in keeping the fire under control and preventing it from spreading beyond the land on which the burning is to take place, **at least 3 able-bodied persons** who shall be constantly in attendance at the fire from the time it is lit until no burning or smouldering fuel is within 30 m of the perimeter of the firebreak surrounding the burnt area or, if there is no such firebreak, within 30 m of the perimeter of the burnt area.
- (7) Where for any day, or any period of a day, specified in a notice given under subregulation (2) the fire danger forecast issued by the Bureau of Meteorology in Perth in respect of the locality where the bush proposed to be burnt is situated is either "catastrophic", "extreme", "severe" or "very high" the permit holder shall not burn the bush in the locality on that day or during that period but may burn the bush in the locality on the first day next following that day or that period on which the fire danger forecast issued by the Bureau of Meteorology is below "very high".
- (8) The permit holder shall not light a fire to burn the bush on a Sunday if the burning of bush on Sundays is for the time being prohibited in the district in which the bush is situated pursuant to regulation 15C(1).
- (9) The permit holder shall not light a fire to burn the bush on a day that is a public holiday in the district in which the bush is situated if the burning of the bush on that day is for the time being prohibited in that district pursuant to regulation 15C(2).

46. General offence

A person who —

- (a) commits a breach of any regulation for which a penalty is not expressly provided; or
 - (b) fails to comply with any condition on which a permit to burn is granted, is guilty of an offence.

Penalty: \$1 000.

9. Easter SMS Messages

The meeting resolved that the following message will be sent out prior to the Easter break

The Shire of Corrigin wishes to advise that no burning is permitted during the Easter period commencing Good Friday 2 April 2021 until Easter Monday 5 April 2021 inclusive.

10. Amendments to the Bush Fires Regulations 1954 – Total Fire Ban Prescribed Activities

The Department of Fire and Emergency Services (DFES) has informed all Local Governments of recent amendments to the Bush Fires Regulations 1954 (the Regulations), that impact business, industry and public authorities, in relation to Total Fire Ban (TFB) prescribed activity conditions.

Initial changes to the Regulations came into effect in November 2019 and after review and feedback from stakeholders further amendments have been made and are now in effect.

A summary of the changes you need to be aware of are as follows:

- Fire extinguisher requirements have been amended for all prescribed activities to be specific for the activity being carried out i.e. can be water or dry powder etc, (see fact sheets for new definition).
- Rubbish collection or disposal services have been added as an essential service.
- Rail grinding is excluded from hot work and an exemption is required, (see hot work fact sheet for rail grinding definition).
- Welding screen requirements for hot work have been amended.
- Road work has been amended to include road work being carried out on a private road (see road work fact sheet for private road definition).
- Off-road spark arrester requirements have been amended.
- Catering conditions have been amended in relation to the fire hose requirements (a standard hose can be used in some cases), approved storage tank definition has been added, and the spark arrester requirements for cooking appliances has changed.
- Fireworks are no longer a prescribed activity and an exemption to conduct fireworks during a TFB is required.

The updated factsheets for each prescribed activity will be sent out with the minutes for your reference.

11. OTHER BUSINESS AND REPORTS

Discussion was held about recognition of service and awards for volunteers. Once Kirsten and Jason have reconciled the list of volunteers and membership dates we will have a better idea of the length of services milestones.
