Council Elections

Local government ordinary elections are held every two years and the next election will be held on Saturday 21 October 2023 across Western Australia.

Local government councillors make many important decisions about the future of your community and we need to have a range of views represented on Council. You can get involved and contribute to the future of your shire by nominating for Council and making decisions about the services to the community such as: recreation buildings; parks and ovals; roads and footpaths; local planning and

development and waste management.

Councillors are elected for four year terms, with half of the Councillors' terms concluding at each biennial election. The Shire of Corrigin has seven Councillors and there are four vacancies in 2023

Meetings are currently held on the third Tuesday of the month at 3pm but the meeting date and time can be changed to suit the majority of Councillors.

Local governments review and update the Owner and Occupier's Roll for their district ahead of the election. If you would like to nominate for Council or vote in the election and are not sure if you are eligible please contact the Shire of Corrigin to check.

Nominations for the October elections open on 2 September and close at 4:00pm on 9 September 2023.

Candidates who are elected in 2023 must complete the Council Member Essentials training within 12 months.

COUNCIL DECISIONS

DEVELOPMENT APPLICATION – PROPOSED NEW DOMESTIC OUTBUILDING

A development application for a new outbuilding, lean-to structure, water tank and retaining wall on Kunjin Street was granted conditional approval.

DEVELOPMENT APPLICATION – PROPOSED NEW FAMILY DAY CARE FACILITY

A development application to establish and operate a family day care facility on Murphy Street was granted conditional approval.

PURCHASE OF COMMUNITY BUS

Council accepted a quote submitted by Fuso Truck and Bus, authorised the Chief Executive officer to proceed with the purchase of the 2023 Rosa Standard 25 seater bus.

PROPERTY SEIZURE AND SALE

Council agreed to the sale of a property on Seimons Avenue due to rates outstanding for 3 or more years in accordance with *Local Government Act 1995*.

ANNUAL REPORT AND ANNUAL FINANCIAL STATEMENTS AS AT 30 JUNE 2022

Council accepted the Annual Report and the audited Financial Statements, auditors report and management report for the 2021/2022 financial year. The annual report is available on the Shire website www.corrigin.wa.gov.au or from the administration office.

Council resolved to hold the Annual General Meeting of Electors on Tuesday 16 May 2023 in the Council Chambers commencing at 6pm to discuss the 2021/2022 Annual Report.

2022/2023 BUDGET REVIEW

At a Special Meeting of Council held on 26 April 2023, Council adopted the 2022/2023 Budget Review in accordance with Regulation 33a of the *Local Government (Financial Management) Regulations 1996*.

PURCHASE AND DISPOSAL OF ONE NEW WHEEL LOADER

At a Special Meeting of Council held on 26 April 2023, Council reviewed submissions received for the purchase of a new loader. The submission from CJD Equipment was accepted as the best option for the Shire and authorised the Chief Executive Officer to purchase a Volvo L90F. Council also authorised the Chief Executive Officer to reject the offer from CJD for the trade of the 2014 Volvo L90F Loader and proceed to auction the existing machine.

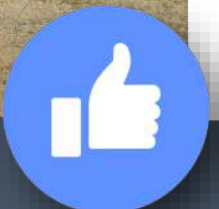
As of Sunday 23 April 2023 we have:

(Patient Assisted Travel Scheme)

Your GP no longer needs to sign your PATS application form

What is the new process?

- 1 You complete a PATS application form and include any requests for consideration outside the current guidelines.
- 2 You submit your PATS application form in person, by post, fax or email to your local PATS office.
- 3 Your application will be assessed internally by WACHS. Your GP may be contacted for additional information, as required to support the decision.
