

The Shire of Corrigin invites applications from local community groups and sporting clubs to crop the Shire owned property known as Rockview to raise funds. The land has been cropped for the past three years by the Corrigin Farm Improvement Group (CFIG) with the current agreement due to expire on 31 December 2024.

The Rockview land is approximately 100 hectares and will be available from 1 January 2025 to community groups and sporting clubs on the basis of either a two or three year plan.

Applicants are required to submit the following details with their application:

- 1. Minutes of the meeting confirming committee support for the application
- 2. Number of years the club or group wishes to crop the land
- 3. Planting program for the period of the lease

Applications will be assessed on:

- Alignment with Shire of Corrigin Strategic Plan objectives
- Need or urgency for funding
- Other fundraising efforts
- Financial reports
