## **GENERAL BUSINESS**

### **Glass Recycling**

N Forbes asked about the glass recycling. The CEO advised that the Shire Corrigin had entered into a new seven year agreement with Avon Waste. The cost of the recycling service increased in the new contract as a result of China no longer buying glass products. Broken glass was a major contaminant of the other recycled products in the recycling bins such as cardboard and also contributes significantly to the weight. The Shire of Corrigin has elected to remove the glass from the recycled bins and it will be either included with the general waste or collections in the blue bins will be used for cover at the Bending Tip.

The Shire of Corrigin will continue to monitor the market for recycled glass and may change the current arrangement in future if an economically viable solution can be found.

It was noted by Cr Gilmore that the Corrigin Waste Transfer Station is reaching capacity and more room will soon be required.
